Terms of Service

1. ACCEPTANCE OF TERMS

Welcome to the Lakes of Mount Dora owner / resident web site also referred to as "LOMD.NET", or LakesNet. The following are the present Terms of Service ("TOS"), which may be updated by us from time to time without notice to you. You can always review the most current version of the TOS at any time in the "Documents" section of the web site.

2. MEMBER ACCOUNT, PASSWORD AND SECURITY

You are solely responsible for maintaining the confidentiality of your password and account, and are fully responsible for all activities that occur under your password or account. You agree to immediately notify the LOMD.NET web administrator (administrator@lcmd.net) of any unauthorized use of your password or account or any other breach of security.

3. MEMBER CONDUCT

- a. We do not accept users attacking each other in any way. This means no posts that threaten, make fun of, or attack others. These posts will be removed. Also, we expect posts to be clean with no foul language or links to offensive sites.
- b. Please do not post copyrighted materials on this site. If you copy and paste copyrighted material, it will be deleted. In addition, no material found on this site may be printed, published, or otherwise used without the written permission of the Lakes of Mount Dora Property Owners Association, the owner of this site.

The residents of the Lakes of Mount Dora, by and through their contracting authority, and pursuant to the provisions of Titles 39 and 47 of the United States Code and the Florida Statutes, as amended from time to time, hereby place the reader and user of this web site on legal notice that the resident information contained herein may not be disclosed, disseminated, or used in any manner whatsoever, including, but not limited to purposes of solicitation of products or services by mail, telephone, or otherwise, without the express, advance written permission of the individual resident.
- g. Any conduct by you that in our discretion restricts or inhibits the use of this site by any other subscriber or visitor will not be tolerated. We reserve the right to pursue any and all legal and equitable remedies against you, including the posting of your address and the reporting of your activity to our partners, your Internet Service Provider (ISP), and other authorities.

Any material in any post that we determine to be disruptive, argumentative, or not suitable for our forum may be edited or deleted at the discretion of our Moderators or Administrators. An email will be sent to any member who has a post deleted for any reason. The notice will be sent to the address displayed in the member's Resident Profile. The Resident Profile email address is a member's responsibility. If an entire thread is deleted only the member who posted the original message will be notified.

If we should fail to enforce any right or provision in these terms and conditions, you agree that this failure does not constitute a waiver of such right or provision.

4. MEMBER RESPONSIBILITIES

You agree to not use the web site to:
